**Terms and Conditions**

As used herein, the term "Caesars Entertainment" shall mean and refer to each of the following entities, individually or collectively, at which a Race & Sports Book ("Race & Sports Book") is operated ("Properties", and individually "Property"), and all of their respective parent, affiliate and subsidiary companies:

- Harrah's Las Vegas, LLC d/b/a Harrah's Casino Hotel, Las Vegas, Flamingo Las Vegas Operating Company, LLC d/b/a Flamingo Las Vegas, Desert Palace, Inc. d/b/a Caesars Palace, Rio Properties, LLC d/b/a Rio All-Suite Hotel & Casino,
- Harrah's Laughlin, LLC d/b/a Harrah's Laughlin, Harvey's Tahoe Management Company, Inc. d/b/a Harvey's Resort Hotel/Casino, Harvey's Lake Tahoe Management Company, Inc. d/b/a Harrah's Casino Hotel Lake Tahoe,
- Caesars Entertainment Operating Company, Inc. d/b/a Harrah's Casino Hotel Reno,
- 3535 LV Corp d/b/a The LINQ Hotel & Parball Newco, LLC d/b/a Bally's Las Vegas, Casino
- Paris Las Vegas Operating Company, LLC d/b/a Paris Las Vegas, and PHWLV, LLC d/b/a Planet Hollywood Resort and Casino.

**I hereby agree to comply with and be legally bound by these rules, to open a Race & Sports Book Wagering Account:**

- 1 To open a Mobile Sports Account for use at Caesars Entertainment Race & Sports Books ("Wagering Account"), patrons must be a Total Rewards Card member and appear in person before a representative of a Caesars Entertainment Race & Sports Book to complete and sign the Mobile Sports Account application. Total Rewards Rules and Regulations are available at <http://www.totalrewards.com/rules>.
- 2 Wagering Accounts may only be used by the person named on the Wagering Account (the "Account Holder"). Account Holder shall not allow representatives or agents to use his or her Wagering Account for any purpose, including to place wagers.
- 3 Account Holders must provide a valid government issued photo identification and complete an IRS form W-9 (if a U.S. resident). Winnings may be subject to IRS reporting and/or withholding requirements.
- 4 Account transactions, including but not limited to deposits, withdrawals, account information changes or account closures must be conducted in person at the Caesars Entertainment Race & Sports Book by the Account Holder, and Account Holder may be required to show valid identification and sign a receipt in order to deposit funds, collect any winnings, make withdrawals or verify account balance.
- 5 A minimum initial deposit of \$5.00 in cash or Caesars Entertainment casino chips is required to open a Wagering Account. All subsequent deposits into a Wagering Account are subject to a \$5.00 minimum deposit in cash, or casino chips.
- 6 The Account Holder will be provided a unique Wagering Account number mirroring their Total Rewards account number and secure personal identification code. It is the Account Holder's responsibility to safeguard and protect account access information. Caesars Entertainment is not liable for any losses arising out of or related to the use of the Wagering Account by any person other the Account Holder.
- 7 Wagering Account activity may only be conducted through the mobile sports application for use at Caesars Entertainment Sports Books ("Mobile Sports App").
- 8 Account Holders must download the Mobile Sports App from either the App Store for iPad and iPhones, or from [Caesars.com/mobile-sports](http://Caesars.com/mobile-sports) for Android devices.
- 9 The Mobile Sports App is currently supported on the ios 7x and above and the Android os version 4.1.2 and above.
- 10 Caesars Entertainment is not responsible for any third party fees incurred by Account Holder, including but limited to, phone usage, charges, text charges, remote access fees and other overages incurred using the Mobile Sports App.
- 11 Caesars Entertainment is not responsible for any damage to Account Holder's mobile device or its operating system that may result from using the Mobile Sports App.
- 12 All decisions made by Caesars Entertainment's management, in its sole and absolute discretion, regarding all aspects of the Wagering Accounts are considered final.
- 13 Wagers will only be accepted from within the State of Nevada. Caesars Entertainment Race & Sports Books are prohibited by law from accepting wagers that originate from out of the State of Nevada.
- 14 Wagers will only be accepted during Caesars Entertainment Race & Sports Book wagering hours, which may be adjusted from time to time by Caesars Entertainment in its sole discretion. You will receive an on-screen notification if you attempt to wager in the Mobile Sports App outside of wagering hours.
- 15 Wagers will be deducted directly from the Account Holder's Wagering Account balance. Winnings from wagers will be credited directly to the Account Holder's Wagering Account, subject to the terms herein and the Terms of Service for the Mobile Sports App.
- 16 All wagers must be a minimum of \$1.00. Wagers exceeding the Account Holder's Wagering Account balance or the Caesars Entertainment Race & Sports Book established betting limits will not be accepted.
- 17 A wager is not considered placed until the Account Holder has verified and confirmed the wager. Once a wager has been placed, it cannot be modified, canceled or voided.
- 18 All applicable taxes are the responsibility of Account Holder. Winnings will not be released to a Wagering Account until all applicable tax forms are completed and received by the Caesars Entertainment Race & Sports Book.
- 19 All applicable Caesars Entertainment Race & Sports Book house rules, which can be found at <http://www.caesars.com/mobile-sports>, apply and may be changed, subject to regulatory approval, at any time without prior notice or liability. The Mobile Sports App is subject to additional terms and conditions available at <http://www.caesars.com/mobile-sports> and <http://www.caesars.com/privacy>. The betting menu on the Mobile Sports App may differ from the over the counter betting menu at Caesars Entertainment Race & Sports Books. Any malfunction of the Mobile Sports App, Race & Sports Book system, or other device or system will void all payouts.
- 20 Wagering Accounts will be suspended after 16 months without wagering activity. To re-activate a suspended Wagering Account, the Account Holder must appear in person at the Caesars Entertainment Race & Sports Book with valid, government-issued photo identification.
- 21 Account Holders must be at least 21 years of age or older.
- 22 Account Holders must not be excluded from any Caesars Entertainment in any jurisdiction.
- 23 Without prior notice or liability, Caesars Entertainment, in its sole and absolute discretion, has the right to (a) refuse to establish, modify, suspend, or close any Wagering Account or (b) reject any Wagering Account deposit or wager. Any or all wagering activity on a Wagering Account may be monitored, recorded and/or reported to law and gaming enforcement agencies.
